# Paperless Operations

Esnad AlRiyad has officially implemented digital contracts and transitioned to fully operational cloud storage systems. The target is reducing paper usage by %90 by 2027. This transition reflects our ongoing efforts to reduce our carbon footprint through digitization. We are actively minimizing paper consumption by adopting digital documentation solutions across all departments.

## Carbon Emissions – Scope 2 & 1

Esnad AlRiyad operates under Riyad Bank and shares the same building and infrastructure. As a result, carbon emissions from Esnad's operations fall under the same calculation and reduction targets as Riyad Bank's environmental strategy. In alignment with this strategy, the combined operations aim to achieve a %24 reduction in Scope 1 and Scope 2 greenhouse gas (GHG) emissions by the end of 2025. This shared commitment supports Saudi Arabia's Vision 2030 and demonstrates our unified approach to environmental responsibility, climate action and our commitment to Net Zero by 2060.







# Social (S):

We are committed to creating a fair diverse and inclusive workplace that aligns with Vision 2030 and promotes employee well-being and growth. As of this reporting period, Saudization stands at %74, our future target for 2027 to increase it to %80, and women represent %39 of our workforce, exceeding Vision 2030 expectation.
